



## Qual boat of the Month

USS Corporal SS 346 1946 to 1972– 2 members qualed aboard her Harold Yingling (8/53) and Bob Patrick (8/64).

DBF! –a <u>Balao-class submarine</u>, was a ship of the <u>United States Navy</u> named for the corporal, an alternate name for the <u>fallfish</u>, found in streams of the eastern United States.

*Corporal* was <u>launched</u> 10 June 1945 by <u>Electric Boat</u> Co., <u>Groton, Connecticut</u>, and she was decommissioned, struck from the US <u>Naval Register</u>, and transferred (sold) to <u>Turkey</u>, under terms of the Security Assistance Program, 28 November 1973. On



12 February 1974 she was commissioned **TCG 2.** *İnönü* (S 333), the second submarine in the third pair named in honor of the <u>Battle of İnönü</u> in the <u>Turkish Independence War</u>.



She was dropped from the <u>Turkish Naval</u> rolls on 2 September 1996, and scrapped. Today, a section of hull containing the stern torpedo tubes is preserved at the Naval Museum at <u>Istanbul</u>.

#### TRI State Base Outreach for members...

We need to reach out to the community to get people to know we are here. USSVI can reach out into the community and hopefully snag some new members. Newspapers and Radio Stations could put out our meeting dates and times. If you know of any stories that could pan out and reach the community.

A past article in the American Submariner had ways to reach out. One idea was to pass out 3X5 cards with our names and a contact number.

Make some USSVI business cards. Keep a couple in your pocket and if you see a Submarine license plate holder or bumper sticker that would belong to a boat sailor, slip a card under the wipers. I recently contacted 3 potential members that way. They will join if they know you are there AND you ask...



You ladies kept us going when all seemed hopeless. You have supported us and kept our minds right! If you have any thoughts you would like to share, PLEASE send them to me. I will publish all that I receive.

Here is a quick tip for people looking for the good deals so they can save money.

- 1) Look in the flyers for what the weekly "special" is. Whether it is chicken breasts or ground beef or steaks, buy enough for you to eat for a full week of recipes.
- 2) Freeze the portions in single serving size. If you are cooking for one, only freeze what you will prepare for each meal and clearly label what the item is and what date you are freezing it.
- 3) If you like to marinate steaks before cooking (or grilling), poke holes in the steak and add marinade before you freeze the steaks. That way, the steaks will slowly thaw and marinate at the same time.

The Supermarket just uses the deal as a "draw" to get you in the store. They usually rotate between ground beef, chicken, steaks, pork and roasts. By buying enough for a week, you can spread it out over a month and with the other items you buy have a nice variety in your menu. If you miss this month's special, it will be back around soon, just pay attention to the flyers. I found that the major area stores usually have a different "draw" item from each other each week. If anything, you have to make sure that you don't buy too much and block your freezer available storage area.

Special tips for ground beef, 1) try to buy 85 to 90% beef. The rest is fat that the butcher throws in. At 85 to 90%, you get enough fat to help in cooking and give flavor but not so much that most of it melts out of the meat during processing. 2) When you buy ground beef in bulk, freeze it as 1/2 cup size patties. You will find that 1/2 a cup will give you 1/4 pound



patties, so if you freeze it and you find you want a hamburger, each burger should be a good size, but if you have a recipe that calls for a pound of beef, all you have to do is pull out 4 burgers!

By doing this buying routine, you will save yourself money and get enough good meat to provide a nice variety!

Here is an interesting story out of WW2 that I had not heard of before. Read it and try to visualize the reaction on both sides.

#### A Navy story from the archives.....

A U.S. Naval history story provided by the Naval Order of the United States.

On April 5th, 1943, the U.S. Navy's Destroyer Squadron 21 was returning from a night of shelling Japanese shore installations deep in the New Georgia area of the Solomon Islands. Our destroyer, the USS O'Bannon, as part of this force, picked up a radar contact that turned out to be a large Japanese submarine cruising on the surface and apparently unaware of our presence. The Japanese lookouts undoubtedly were fast asleep.

We approached rapidly and were preparing to ram the sub. Our captain and other officers on the bridge were trying to identify the type of sub and decided, at the last minute, that it could be a mine layer. Not wanting to blow up ourselves along with the sub, the decision was made that ramming was not a wise move. At the last moment, the rudder was swung



hard to avoid a collision and we found ourselves in a rather embarrassing situation as we sailed along side of the Japanese submarine.

On board the sub, Japanese sailors, wearing dark shorts and dinky blue hats, were sleeping out on deck. In what could be considered a rude awaking, they sat up to see an American destroyer sailing along side. Our ship however, was far too close to permit our guns lowered enough to fire and since no one on deck carried a gun, not a shot was heard. Ditto on the Japanese sub, no one there had a gun either. In this situation, no one seemed sure of the proper course of action and it probably would not have been covered in the manual

anyway. Therefore everyone just stared more or less spellbound.

The submarine was equipped with a 3 inch deck gun and the sub's captain finally decided that now was probably a good time to make use of it. As the Japanese sailors ran toward their gun, our deck parties reached into storage bins that were located nearby, picked out some potatoes and threw them at the sailors on the deck of the sub. A potato battle ensued. Apparently the Japanese sailors thought the potatoes were hand grenades. This kept them very busy as they try to get rid of them by throwing them back at the O'Bannon or over the side of the sub. Thus occupied, they were too busy to man their deck gun which gave us sufficient time to put a little distance between our ship and the sub. Finally we were far enough away to bring our guns to bear and firing commenced. One of our shells managed to hit the sub's conning tower but the sub managed to submerge anyway. At that time our ship was able to pass directly over the sub for a depth charge attack. Later information showed that the sub did sink. When the Association of Potato Growers of Maine heard of this strange episode, they sent a plaque to commemorate the event. The plaque was mounted in an appropriate place near the crews mess hall for the crew to see.

Well, it was the crew's battle.

The story was picked up by the papers back in the States and, shortly thereafter, a full blown account of the event was covered by a story in the READERS DIGEST. Conversations with a crew member that served years later revealed that, while the plaque was still located in the crew's mess hall, no one seemed to pay much attention to it nor knew much about it. I guess the crew was interested in making history but not particularly interested studying it.
