BYLAWS change

I uncovered an item that bothered me in our bylaws. I want to make sure that the Base is protected, especially from a person "going rogue". At this time, the only expenditures that can be paid by the treasurer are those that are presented by the Commander, but there is no requirement or protections as to limit AND the treasurer can pay bills (not expenditures) that the Commander presents. So, a proposed change has been presented to the membership by FLASH TRAFFIC and a special BOD meeting before the June Picnic has been requested to discuss the Torpedo, bylaws and general direction for the Base.

A summary of the recommended changes is as follows:

Under Article VII, Section 1 -

 Shall make a request at a meeting, (regular, special or electronic) and receive a simple majority of approval of votes cast, prior to authorizing any expenditure of greater than \$100.
Under Article VII, Section 4 –

All expenses in excess of \$100.00 shall be voted on at a base meeting, regular, special or e-meeting and receive a majority of present membership and presented to the Base Commander for approval before payment;

Under Article X -



7 Jun 2014 - Change to article VII sections 1 and 4 to require base approval by vote before expenditures of greater than \$100 can be sanctioned by the Base Commander and made by the Base Treasurer.

QUAL BOAT OF THE MONTH: USS GRAMPUS (SS 523)

Members who qualified on the Grampus include: Fred Keller and Herb Lopp.

History of USS Grampus (SS-523)

USS *Grampus* (SS-523), a *Tench*-class submarine, was the seventh ship of the United States Navy to be named for two members of the dolphin family (Delphinidae): *Grampus griseus*, also known as Risso's dolphin, and orca, also known as the "Killer Whale." Her keel was laid down on 8 February 1944 at Boston Navy Yard. She was launched on 16 December 1944, but World War II ended before she was completed, and she sat idle until construction resumed in 1948. On 26 October 1949, she was both christened (by Charlotte Linné Woodward, wife of Vice Admiral Clark H. Woodward, who also sponsored the previous *Grampus*) and commissioned, with Commander George F. Sharp in command. **1949-1966**

With her new snorkeling equipment, which permitted her to remain submerged for periods far longer than the World War II fleet submarines, *Grampus* served as a prototype for the GUPPY submarines and also incorporated many features to appear later in nuclear submarines. Attached to SubDiv 61 at Norfolk, Virginia, she participated in a variety of exercises along the East Coast and in the Caribbean Sea, including torpedo and attack exercises, snorkeling tests and demonstrations, and antisubmarine training. *Grampus* also did a great deal of work with the early HUK (Hunter-Killer) antisubmarine patrols, now a vital part of American defenses, to whose development she greatly contributed.



USS Grampus Underway

From 5 January to 2 April 1955 *Grampus* proceeded independently to the Mediterranean Sea, where she "showed the flag" at Algiers, Naples, Barcelona, Malta, Beirut, Monaco, and Gibraltar before returning to Norfolk and her routine of exercises and tests, spaced with regular overhauls at Portsmouth, New Hampshire, and Philadelphia, Pennsylvania. During the late 1950s and early 1960s *Grampus* operated out of Norfolk in the North Atlantic.



Under the command of Lieutenant Commander D.A. Kilmer, *Grampus* sailed with Task Force "Alfa" for six weeks prior to 13 February 1964. On 3 April, she deployed with the Sixth Fleet in the Mediterranean Sea until 3 August.

She operated out of the Virginia Capes until entering Philadelphia Naval Shipyard in mid-April 1965 for overhaul. After refresher training and shakedown in the fall, *Grampus* operated along the East Coast engaging primarily in ASW exercises.

She departed Norfolk, Virginia, on 13 May 1966 for the eastern Atlantic and Northern European countries to participate in NATO ASW exercises. Back in Norfolk on 30 August, she resumed operations in the Virginia Capes area and Caribbean Sea until sailing 29 December to Philadelphia, Pennsylvania, for repairs in the naval shipyard. Shipshape again, she resumed operations with the Atlantic Fleet.

1967-1981 (Decommissioning and service for Brazil)

Grampus was decommissioned and struck from the Naval Vessel Register on 13 May 1972, and sold under the Security Assistance Program to Brazil, where she became *Rio Grande do Sul* (S-11). (She replaced the previous *Rio Grande do Sul* (S-11), ex-*Sand Lance*.) After six years of service, she was decommissioned on 16 November 1978 and scrapped on 18 June 1981

DOWN HOME BAKED BEANS This is a simple recipe for baked beans, and oh so good.


Donation Agreement (Conditional Deed of Gift)

THIS AGREEMENT between the HAWTHORNE ORDNANCE MUSEUM of 925 E Street, P.O. Box 2008, Hawthorne, Nevada 89415, hereinafter called "the Donor" and The United States Submarine Veterans, Inc. (USSVI) - Tri-State Base, hereinafter called "the Donee"; located at 2 Donovan Court Brunswick, MD 21758.

WITNESSETH:

WHEREAS the donor did acquire at his own expense, certain inert MK-37 MOD 3 Torpedoes in pristine condition on September 29, 2012 (shown right) from the demil account of the operating contractor of the Hawthorne Army Depot (HWAD) for the specific purpose of creating historic and accurate displays so that a realistic representation of the various torpedoes used by the U.S. Navy could be made, and

WHEREAS the Donee has applied for the following by his letter of 20-March-2014 specifically for the donation to Donee's organization of:



• One qty, MK-37 MOD 3 Fitment Torpedo (inert), complete with rail-guides, guidance fins and propulsion section installed; pristine condition held in a MK 318 Mod 0 Shipping container for the purpose of a memorial-parade float.





HAWTHORNE Ordnance Museum

All assets originate from the Donor's facility in Hawthorne, Nevada, and Donor and his volunteers have worked hard to select the best example of the before mentioned shapes with shipping to be provided by Donee to Donee's address. Further, the Donor hereby states that all TORPEDO shapes are obsolete. No further demil work is to occur to the listed property without authorization by the Donor.

NOW THEREFORE, in consideration of the premises and the mutual agreements hereinafter set forth, the parties hereto agree as follows:

1. The Donor agrees (a) to release the MK-37 Torpedo on an "as is, where is" basis and without warranty of any kind implied or expressed and (b) to notify the Donee of the available date sufficiently in advance thereof to enable the Donee to make necessary arrangements for

shipping of the herein listed assets to Donee's address.

2. The Donee acknowledges that Donor did have volunteers open the shipping containers on 19-October-2012 and found the torpedoes were inert and that no explosives or hazardous materials of any kind were found . The Donor certifies that the Warhead space is EMPTY and HOLLOW and



contains no parts at all (shown right).

- 3. The Donee agrees to accept the property on an "as is, where is" basis and be responsible for all arrangements and costs in the shipping and delivery of assets.. The Donee shall, at no cost to the Donor, arrange and pay for any disassembly, packing, transportation and other actions as necessary for the movement of the donated property to the Donee's display location.
- 4. The Donee acknowledges that the donated property were training shapes for a former and now obsolete torpedo system and shall use the donated property in a careful and prudent manner, and shall maintain it and make such repairs to it as are necessary to keep it in a clean and safe condition so that its appearance and use will not discredit the Donor and the previous owner; the United States Navy. The Donee also agrees not to use the donated property as security for any







loan, nor sell, lease, rent, exchange the property for monetary gain or otherwise under any circumstances without the prior written approval of the Donor.

- 5. The Donee shall indemnify, save harmless, and defend the Donor from and against all claims, demands, actions, liabilities, judgments, costs, and attorney's fees, arising out of, claimed on account of or in any manner predicated upon personal injury, death, or property damage caused by or resulting from possession and/or use of the donated property.
- 6. The Donee agrees to allow authorized representatives of the Donor reasonable access to the Donee's records to assure accuracy of the information provided the Donor and compliance with

the terms of this Conditional Deed of Gift.

7. Title is transferred on special condition that the donated property not be transferred or otherwise disposed of including redonation without the written consent of the Donor. If disposition by any



method (including additional redonation) without consent of the Donor is attempted, title to the property is subject to forfeiture and the Donor may require return of the property by the Donee or may repossess the property from whomsoever may have possession thereof and the Donee shall bear all expenses of return and repossession as well as all storage costs.

Upon the failure of the Donee to observe any of the conditions set forth in this Conditional Deed of Gift, title to the donated property shall revert to and vest in the Donor. Repossession of all or any part of the donated property by the donor shall be at no cost or expense to the Donor, and the Donee shall pay all maintenance, freight, transportation and either charges attributable to such repossession.

- 8. When the donated property is no longer required by the Donee, disposition instructions will be requested from the Donor. All costs of disposition will be borne by the Donee.
- 9. Subject to the conditions set forth herein, title to the property shall vest in the Donee upon receipt of written acceptance hereof from the Donee.
- 10. The Donee shall certify, upon request from the Donor, the condition and location of the donated items.
